3. Entire original bidding documents and firm's legal documents, certificates should be endorsed (affixed stamp and signature) in all pages.
4. Powers of Attorney in favor of person(s) signing the bid that such person(s) is/are authorized to sign the bid on behalf of the bidder and consequences resulting due to such signings shall be submitted with bidding document.

Bidders should submit a bid amount of NRs. 150,000.00 (Nepalese Rupees One Hundred Fifty Thousand Only) for Baidam Branch, NRs. 100,000.00 (Nepalese Rupees One Hundred Thousand Only) for Gagangaunda Branch, NRs. 100,000.00 (Nepalese Rupees One Hundred Thousand Only) for Begnas Taal Branch and NRs. 300,000.00 (Nepalese Rupees Three Hundred Thousand Only) for Regional & Branch Office: Butwal either through cash deposit on Muktinath Bikas Bank Ltd A/c no. 01392774101008 (BID MONEY PAYABLE) or Bid Bond which is valid up to 30 days beyond last date of bid submission.
