4. Experience Letter of construction work carried out in at least 3 banks of Nepal. And the Technical Document should submit separately.
5. Powers of Attorney in favor of the person(s) signing the bid that such person(s) is/are authorized to sign the bid on behalf of the bidder and consequences resulting due to such signings shall be submitted with a bidding document.
